Jean,

Section 2-11.1(bb) requires execution of an affidavit by the elected official. The certificate that is presented to the official is not an affidavit and is not signed by the official, so that would not suffice to satisfy the ordinance. This requirement applies to all elected officials in municipal government in the county per Section 2-11.1(a) of the Code. I have attached a sample affidavit used by County officials which can easily be adapted for any municipality. I hope this answers your questions, but please feel free to call if you have anything further. Joe

Each elected official, as defined in subsection (b)(1), shall, within ninety (90) days after being sworn into office, submit to the Clerk of the Board a certificate of completion of an ethics course offered by the Miami-Dade County Commission on Ethics and Public Trust ("Ethics Course"). ..."

> Here are my questions:

> 1) I understand that incumbent CMB election officials took the County Ethics training last year, and they each received the certificate of completion of ethics training which certificate was filed with the City Clerk--no need to file with "Clerk of the Board", correct?

> 2) The "affidavit" referred to in first sentence of (bb) above does not apply to CMB elected officials, correct?
