Mr. Benson:

You have inquired regarding whether representatives of Verizon Wireless would need to register as lobbyists with Miami-Dade County in order to discuss plans of sales operations with Miami-Dade County agencies, in view of the existence of a State of Florida Wireless Contract under which Verizon Wireless is an approved vendor. You suggested that it is your belief that such representative would not need to register inasmuch as they would be accessing an existing contract that would not require the approval of the Mayor or County Commissioners.

Please be advised that, based upon information received from the County's Internal Services Department (ITD) (see below email), it appears that the County has an enterprise contract in place that is managed by ITD on behalf of the County, which was awarded to AT&T via a full and open RFP process. This contract has been in place since 2008 and the County has no other Countywide contract for wireless devices and services. Accordingly, in order for the County to consider utilizing Verizon Wireless for such services, there would need to be an open and competitive process that would involve an advertisement, a selection committee, and the involvement of both the Mayor and County Commission in the final decision.

Therefore, it is my conclusion that any representative of Verizon Wireless seeking to influence a Miami-Dade County decision to utilize its services in this area would require lobbyist registration and compliance with all relevant provisions of Section 2-11.1(s) of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance.

I would like to thank you for taking the time to speak to me a few weeks ago. Based on that conversation, I would like to lay out Verizon Wireless (VZW) plans of sales operation for Miami-Dade County Agencies.

First, VZW will only sale to the Miami-Dade County agencies from the State of Florida Wireless Contract, which was executed nearly four years ago after a competitive bidding process.

Second, purchases from this contract require no Board of Commissioners action. The Agencies simply issue an order for the products and services and reference and accept the terms and condition of the State of Florida Wireless Contract.

Finally, VZW will complete all of the necessary Vendor Registration forms, as required. However, at this time, VZW will not be registering any employees as Vendor Lobbyists because no VZW employees will have any interaction with the Commissioners or their staffers and will not attempt to influence any Board action or decision.

If any of the steps that VZW plans to take as it begins sales calls with Miami –Dade agencies is a violation of any Miami-Dade ordinance or ethics rule, please let me know and we will rectify that violation. Otherwise, could you reply that you see no ethics issue with the plan above.
