## Ms. Castro,

You inquired on behalf of Commissioner Rebeca Sosa regarding whether she could vote on the attached item related to Value Adjustment Board Proceedings, which involves issues concerning the overall funding provided to the School District from Miami-Dade County tax revenues. This request was made in view of her fulltime employment with the School District at the Lindsay-Hopkins Technical Education Center.

As I indicated to you prior to the vote, it was permissible for Commissioner Sosa to vote or participate in this matter because there was no direct correlation between her position with the school district and this item. The school district is a vast enterprise and any change in funding to the overall district from this measure would have no perceptible effect on Commissioner Sosa in her position with the district that would create a voting conflict under Section 2-11.1(d) of the Ethics Code Ordinance. Since the School District is a governmental organization rather than a private business, and because she would not stand to profit or be enhanced by this item, there is no prohibited conflict of interest.
