Good afternoon Ms. Olano,

You inquired whether a Board alternate or proxy member for the Homeless Trust is required to file financial disclosure forms.

Proxy board members for the Homeless Trust must file financial disclosure forms for the years during which they are/were able to participate, even if they do not actually participate that year. *See Sec. 2-11.1(i) of the County Ethics Code*. The Ethics Commission has reasoned that because individuals are approved and authorized to serve in an advisory capacity and because they may be subjected to undue influences as a result of their potential service, they must file financial disclosure statements by July 1st following each year during which they were eligible to serve on the board. *See RQO 13-01; INQ 13-77.*

This opinion is based on the facts presented. If these facts change, please contact me.
