You have inquired regarding whether there would be any ethical issue under the Miami-Dade Conflict of Interest and Code of Ethics Ordinance, for you to accept an appointment by the Miami-Dade School Board as an unpaid member of the Pathways to Biliteracy in Elementary Education Task Force. You are currently employed full-time by the County as Director of the Hispanic Affairs Advisory Board, which operates out of the Community Advocacy Division, Office of the MDCC Chair. The appointment would place you on a School advisory board with other community leaders to assist in developing and implementing a diversified World Language Program. I do not see any problem with this, either under Section 2-11.1(j) or 2-11.1(g) of the Code in that it appears to be completely consistent in my judgment with your position in the County in dealing with an important issue related to Hispanic affairs, and would not interfere with your independence of judgment in fulfilling your County duties. In my opinion, you would be justified in serving on this board during County time and would not in any way be abusing or exploiting your position in the County, insofar as it is an unpaid position commensurate with your overall County duties. I do strongly suggest that you get prior permission from whoever is considered to be your supervisor for your participation on this board to avoid any issue regarding your authorized participation.
