Ms. Aguirre;

You have inquired on behalf of Miami-Dade County Commissioner Rebeca Sosa regarding whether she may go on an inaugural cruise of a new ship being launched in November by Norwegian Cruise Lines. I understand that Commissioner Sosa received the invitation for her and her husband to attend a complimentary cruise extended to regular cruise line patrons as a promotion for the new ship. It is Commissioner Sosa's understanding that the invitation was not extended to other Commission members, but was made to her based upon her frequent cruise-taking. To her knowledge the other persons on the cruise will be other frequent cruisers like herself, none of whom will be paying for the cruise. The cruise itself is not a regular cruise which is open to the public, and is a two-day cruise that will not stop at any ports, but will simply cruise out to sea and return to the port. Commissioner Sosa has taken the step of requesting that the cruise line give her a price that could be paid for the cruise, which is \$99 per person, per night. Commissioner Sosa has also indicated that there will be a ceremony held in the port at the launching of the ship prior to the cruise, in which she will participate along with other County officials. However, there is no connection between the ceremony and the cruise itself.

Under Section 2-11.1(w) of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, it would generally be prohibited by that section for any County official or employee to accept travel or travel-related expenses from any County contractor, vendor, service provider, bidder or proposer. Norwegian Cruise line is a County contractor based on its contract to operate out of Port/Miami, a County agency. Regardless of the fact that the offer was extended to her not as an official but as a frequent cruiser, Commissioner Sosa could not accept a complimentary cruise from Norwegian Cruise lines. Given however, that she will be paying for the cruise for herself and her husband, and that the opportunity is not being offered to her based upon her position as County Commissioner, it is my opinion that she may go on the cruise under these given circumstances.
