Mr. Murray:

You have inquired on behalf of Ken Pyatt, Deputy Director of the Miami-Dade Aviation Department (MDAD) regarding whether it would be prohibited under the Miami-Dade Conflict of Interest and Code of Ethics Ordinance for Mr. Pyatt to have his lodging at an upcoming conference paid for by RIB/US COST, a County contractor doing business at the airport. The conference is the iTWO World Conference being held at the Four Seasons Hotel in Hong Kong on November 18-19, 2015. Mr. Pyatt has been invited by RIB to be a speaker at the conference and its coverage of expenses would be limited to lodging at the conference. The County will be paying for his travel and other incidental expenses.

The issue is whether the payment of the lodging expenses by a County contractor under these circumstances is prohibited by Section 2-11.1(w) of the County Ethics Code. That section prohibits acceptance by County officials or employees of "any travel expenses, including, but not limited to, transportation, **lodging**, meals, registration fees and incidentals from any County contractor, vendor, service provider, bidder or proposer." (Emphasis added) There is no exception under that subsection where the individual involved happens to be making a speech at the event. The only waiver provision in that subsection would require that the County Commission waive the requirements of the subsection by majority vote. Unless that were to happen, Mr. Pyatt could not accept the complimentary lodging from a County vendor. It would not, however, be inappropriate for the County to pay for the lodging, assuming Mr. Pyat is appearing at the event in his official capacity, or for Mr. Pyatt himself to pay for his own lodging, provided that he accept no other payment of travel or travel-related expenses from RIB.
