The County distinguishes between lobbyists and principals. Under Section 2-11.1 (s) of the County Ethics Code, if you are a paid outside lobbyist for a corporation, you are required to register and pay the fee. If you are an employee or board member or shareholder of a corporation and you are person designated to represent the corporation in lobbying, then you still need to register but would not be required to pay the fee. Both lobbyists and principals who lobby are required to take the ethics course.
