Dear Ms. Swain,

You inquired whether Mr. Rafael Terrero, former Assistant Director of Wastewater for Miami-Dade County Water & Sewer Department (WASD), may be hired by your firm to participate in a project involving the City of Hialeah Department of Water & Sewer.

As background, your firm, Milian, Swain & Associates, Inc., is a consulting engineering firm that provides engineering and management services to Miami-Dade County, municipalities and private entities. You are considering hiring Mr. Terrero to participate in a project for the City of Hialeah, specifically, to review and make recommendations with respect the city's wastewater procedures. You would like to know whether the County Ethics Code would prohibit him from participating in this project.

The County Ethics Code at Section 2-11.1(q) ( "two-year rule") provides that " no person who has served as an elected County official,..... department director, **departmental personnel** or employee shall for a period of two years after his or her county service or employment has ceased, **lobby** any *County* officer, departmental personnel or employee, in connection with any judicial or other proceeding, application, RFP, RFQ, bid, request for ruling or other determination, contract, claim, controversy, charge or accusation in which *Miami-Dade County or one of its agencies or instrumentalities* (emphasis added) is a party or has any interest,... direct or indirect." The prohibition affects those former employees who intend to lobby ,ie., influence any official decision in the County made by County officials, personnel or employees. Consequently, Mr. Terrero would not be prohibited from participating in a project involving the City of Hialeah.

Should the opportunity present itself where your firm wishes to engage the services of Mr. Terrero in a project involving the County, which is another of your clients, be mindful that Section 2-11.1(q) precludes Mr. Terrero from **lobbying** the County for two years on behalf of himself or his employer. Lobbying activities under the two-year rule include advocating for official decisions to be made at the sole discretion of <u>any</u> County personnel. However, while Mr. Terrero is precluded in the next two years from arranging or participating in meetings between your firm and the County for the purpose of influencing elected officers and/or County employees to take official action or make an official decision, Mr. Terrero would not be prohibited from providing services related to County projects or meeting with County staff as long as any appearance is related to an *awarded contract* (emphasis added).

In addition, former County employees are cautioned that they may not engage in any activity which would require them to disclose confidential information acquired by reason of their official position with the County, nor use such information, directly or indirectly, for their personal gain or benefit. *See* Section 2-11.1(h), Miami-Dade County Ethics Code.
