Mr. Betancourt:

In response to the three issues raised in your email, please be advised as follows:

2- Miami-Dade Aviation Department may request contract references from Mr. Jose Abreu, former Aviation Director, and Mr. Juan Carlos Arteaga, former WASD Deputy Director for Regulatory Compliance & Capital Improvements, as long as they are compliant with the two-year rule under Section 2-11.1(q). If either Mr. Abreu or Mr. Arteaga is less than two years from his termination date from County employment, then he should not be lobbying on behalf of any entity appearing before a County advisory board, pursuant to Section 2-11.1(q). Merely providing a reference at the request of the County would not be considered lobbying, but any other attempt on the part of such an individual to influence a County board could be a violation of the rule prohibiting former County employees from lobbying the County for a period of two years. If either Mr. Abreu or Mr. Arteaga is employed by or has a current business relationship with the entity, I would advise against asking them for such a reference. If the sole basis of the reference is their experience with the firm while in County employment, then I would not see a problem with it.
