You have inquired regarding whether officers or employees of the City of Miami may accept a complimentary ticket from the Latin Builders Association for attendance at its membership cocktail valued at \$35, and if accepted, whether it would need to be reported unless th amount were less than \$25.

No officer or employee of the City should accept any complimentary ticket to a private event if it is in violation of either Section 2-613 of the City of Miami Code or Ordinances or Section 4(C) of the City of Miami Charter, or is provided for or because of any decision or action that the official or employee may have taken or will be taking in his or her official capacity (Section 2-11.1(e)(3), Miami-Dade County Code).

If the gift is not prohibited under any applicable law or ordinance, then the gift would have to be reported if it is in excess of \$100 (Section 2-11.1(4), Miami-Dade County Code). The threshold for reporting may be lowered by a municipality by local ordinance, but I am not aware that that has happened in the City of Miami. Therefore, a legally acceptable gift in the amount of \$35 would not need to be reported.
