## Mr. Smith:

You have inquired regarding whether there is any prohibition to your being listed as a professional reference by Ch2M Hill, in connection with ISD Project No. E15-WASD-12, County project involving the provision of engineering services for proposed upgrades to the Miami-Dade SDWWTP and its appurtenant facilities. It is my understanding that this project is separate from and unrelated to the existing contract that CH2M Hill has with WASD for management on behalf of the County of multiple projects included in WASD's Ocean Outfall Legislation Program, for which you serve as a program manager. You are not involved with E15-WASD-12 in your County capacity, will exercise no oversight over it, and will not be serving on any selection committee formed to make a recommendation concerning that project. This request

has been made for you to be a possible reference based upon your professional experience in working with CH2M Hill on projects involved in Ocean Outfall Legislation Program.

As a County employee, you may be utilized as a reference for CH2M Hill under the foregoing circumstances, since I do not see any conflict with your professional responsibilities of your current County position. You may provide information upon request to other County officials, employees or the selection committee concerning your experience with CH2M Hill. It would be appropriate for you to notify your supervisor of this request, in the event that there are any policy reasons for you to refrain from such involvement. In any event, I would caution you to provide only the information you may be requested to provide, and to refrain from acting as an advocate for CH2M Hill or to initiate any unrequested contact with or appearance before those involved in the decision-making process in an attempt to influence the decision either for or against CH2M Hill. This would avoid any violation of Section 2-11.1(m), which prohibits departmental personnel and employees from appearing before any County board or agency to make a presentation on behalf of another party on a contract or decision involving that party.
