Carolina:

IRS policies provide that an unsigned federal tax return is not valid (*see* e.g., <u>http://www.irs.gov/pub/irs-pdf/i1040gi.pdf</u> and IRS 1.2.12.1.5 (07-26-2011)-Policy Statement 3-5, indicating that unsigned income tax returns will not be accepted for processing).

The County Ethics Code at 2-11.1 (i) specifies that one of the documents that may be submitted by County filers to satisfy the requirements of this section is a current income tax return. Given that an unsigned federal income tax form would be invalid, it follows that providing an invalid tax form would not meet the requirements of 2-11.1(i). Furthermore, both State and County financial disclosure forms require a signature. This standard should be applied uniformly. Consequently, County filers must submit a signed federal Income Tax return.
