Ms. Castro:

You have inquired on behalf of Commissioner Rebeca Sosa regarding whether the Commissioner has a voting conflict under Section 2-11.1(d) of the County Code of Ethics in voting on or otherwise participating in Item No. 150543, a Resolution that would authorize the County to acquire certain lands in the western part of the County. The reason for the request is that Commissioner Sosa has a fulltime position with the Lindsey Hopkins Technical Education Center in the Miami-Dade County Public School District and the School District would be compensated pursuant to the Resolution for its current leasehold interest in a portion of the land that the County intends to acquire. The land in question is not situated within Commissioner Sosa's district and the School Board's leasehold parcel is currently unoccupied and was contemplated to be used for a school facility at some unspecified future time.

Because the School Board is a governmental agency rather than a private entity, we have in the past not considered one's position with the School Board to automatically disqualify a School Board employee on a County board from voting on or participating in an item that might affect the School Board. We look at the particulars of the transaction to determine whether the individual stands to profit or be enhanced in some way by the transaction to determine whether a conflict exists. In this situation, where the issue in question would have no perceptible effect on Commissioner Sosa's position at Lindsay Hopkins, nor would it in any way enhance or profit her in any way distinguishable from that of the general public, I do not find that there is any voting conflict of interest under Section 2-11.1(d). Accordingly, Commissioner Sosa may vote or otherwise participate on this item when it comes before the County Commission.
