## Mr. Annunziato:

You have inquired on behalf of Vice-Chair Esteban Bovo whether he may participate in a fundraising drive to raise funds for the First Generation Scholarship Fund at FIU. The program offers scholarships to FIU students who are first in their family to receive a college education. Vice-Chair Bovo will make personal telephone calls to FIU alumni to solicit funds for this cause. You have informed me that the funds will be routed through the FIU Foundation, a 501(c)(3) non-profit entity. It is my understanding that neither Vice-Chair Bovo nor his staff will be receiving compensation as a result of the solicitation. All funds raised through the solicitation will be going to this cause.

Pursuant to Section 2-11.1(e)(2)(g), there is an exception to the general prohibition on solicitation of gifts by Miami-Dade County officials and employees. Under the exception, gifts solicited by Miami-Dade County Commissioners or staff members on behalf of a 501(c)(3) nonprofit organization, where neither the commissioner nor the commissioner's staff receive compensation for the solicitation, are exempt from the definition of a "gift." Accordingly, I have concluded that Vice-Chair Bovo may engage in the solicitation on behalf of the First Generation Scholarship Fund at FIU.
