Ms. Jeannette-Amodeo:

I see no ethical prohibition with the Miami-Dade Youth Commission, a government agency, sponsoring an appreciation reception for members of the BCC. I also should not be a problem for the South Beach Group and Collins Park Neighborhood Association providing the venue and refreshments. The only issue I could foresee would be if either of those private groups happened to be a County lobbyist or contractor or political committee, and the value of the contribution amounted to more than \$100 per elected official, in which case those gifts would be prohibited under State Law. Based on the facts you have presented, it appears very doubtful that that would be the case, and, assuming there

is no quid pro quo envisioned by these groups on any pending matters before the BCC, there should be no problem with the reception.
