Ms. Morley,

You have inquired on behalf of Kevin Kirwin, Parks Director for the City of Miami, regarding whether he may accept appointment to Friends of Belafonte-Tacolcy Park. Belafonte-Tacolcy Park (BTP) is a park within the City of Miami and, therefore, one of the parks overseen by Mr. Kirwin in his role as Parks Director. The City of Miami currently has a contract with a non-profit entity, Belafonte-Tacolcy Center, Inc., for the provision of sports development and after school services at the park. The newly formed group, Friends of BTP, is a non-profit group that is being formed for the purpose of raising funds for BTC in connection with its programs at BTP. You have been requested by U.S. Representative Fredricka Wilson to participate on this board with other community leaders in an effort to save and continue some of the programs at the park through private fundraising efforts.

The involvement of public employees in private fundraising efforts for public purposes, while not necessarily impermissible under the Ethics Code, does raise issues regarding possible appearances of impropriety, depending on whether the solicitations are made to City contractors or lobbyists. Further, since the fundraising is to be done on behalf of a City contractor, the involvement by the City Parks Director in the effort may place Mr. Kirwin in a situation where he may be essentially recommending or will be perceived as recommending the continuation of an existing contract on behalf of a City contractor, BTC. Such activity could constitute a violation of Section 2-11.1(p), which prohibits recommendation of services by a person or firm, professional or otherwise, in a transaction involving the City. In addition, Section 2-11.1(j) prohibits conflicting employment which would impair the independence of judgment of a City employee in the performance of his or her public duties. While service on a non-profit fundraising board would not qualify as outside employment under the ordinance, an analogous issue is raised in connection with such service in this instance because of the distinct possibility that Mr. Kirwin's efforts on behalf of BTP could interfere with his independence of judgment regarding allocation of City resources to BTP or to other parks under his supervision.

While Mr. Kirwin's prospective service on the board of Friends of BTP may not clearly violate the provisions of the Code of Ethics, there are enough concerns raised by the inherent conflicts which could result from such service, that it is my recommendation that Mr. Kirwin decline the appointment to the Friends board. However, I would not see any problem with Mr. Kirwin's making himself available to consult with the Friends board to discuss the needs of BTP or the state of its existing programs and facilities, as such consultation would fall within his public duties as Parks Director.
