**Subject:** INQ 16-76 Luis Aguiar, Assistant Director, Water System Operations, Miami-Dade County Water and Sewer Department (Two-Year Rule, Confidential Information)

Mr. Aguiar:

You have inquired regarding the ethics restrictions that may apply to you following your retirement from the Miami-Dade County Water and Sewer Department (WASD), where you are currently employed as Assistant Director. Following your retirement, you plan to work with private firms that may include a consultant, contractor or service provider with WASD. You understand that you will not be permitted to lobby on behalf of these companies for two years pursuant to Section 2-11.1(q) of the County Code.

While you may be employed following your retirement with firms that do business with the County, you should be made aware that, for purposes of the two-year rule, you are subject to a narrower definition of lobbying than the definition of lobbying in the County Code. Please review the Frequently Asked Questions Memo and RQO 12-09 attached to this email, which explain that within the two-year period, you may not meet with any county personnel for the purpose of influencing a decision by such personnel at any level. You may interact with County employees in connection with ministerial matters, such as submitting paperwork or obtaining information, but you must be careful not to attempt to persuade anyone in connection with a discretionary decision. The attached Memo and opinions will provide you with further information about the restrictions of the Two-year rule.

Additionally, in the event that you have been made privy to any confidential information in the course of your County employment, you may not disclose that information to an employer or use that information for your personal benefit pursuant to Section 2-11.1(h) of the Code.
