RE: 2016 Public Housing and Community Development Housing Assistance Inquiry

Requests (H-INQ Files)

The Miami-Dade County Ethics Code at Sec. 2-11.1 (c)(5)(5) provides that County employees or their immediate family members who are otherwise eligible for assistance through the PHCD should be permitted to seek such assistance as long as the County employee does not administer the program.

Given that these applicants qualify for the housing assistance program they are applying for and their job responsibilities **will not require them to be involved in any way in the administration of the housing program;** and given that none of their immediate family members oversee or administer said programs, staff has recommended the following disposition:
