Dear Mr. Chao,

It was a pleasure speaking with you. Thank you for the additional information you provided. You inquire whether you and your wife need to request permission to engage in outside employment.

As background, you are employed as a Sr. Specialist in the County's 311 Communications Department. Your wife is employed as a Real Estate Evaluator in the Property Appraiser's Office. You own Modern Martial Arts and Fitness, a martial arts school where you teach classes ranging from kickboxing to Krav Maga. Your wife is listed as an officer of the business but she does not perform any work for the business and is not compensated. Although you initially stated you are a County vendor, it was later clarified that you are not a County vendor because you do not transact business with the County; rather, you are considered a County participating merchant. (This means you are a Miami-Dade County Employee Discount member which, among other perks, entitles you to free placement of your business on the County Employee Discount website).

The Miami-Dade County Code at Section 2-11 requires all full-time employees to seek yearly permission before engaging in outside employment. *See also* AO 7-1. Additionally, Section 2-11.1(k) requires the employee to complete a financial disclosure form on a yearly basis. A business owned by a County employee, regardless of whether the business is generating income for the employee, is considered outside employment. Consequently, you are required to obtain written approval from your supervisor. With respect to your wife's responsibilities, the Ethics Commission has opined that being listed as an officer in a spouse's business where the person does not perform any services for that business and receives no compensation <u>is</u> <u>not</u> considered outside employment. RQO 07-24, RQO 08-36, INQ 05-37. Consequently, your wife is not required to obtain written approval to engage in outside employment.

This opinion is based on the facts presented. If any of these facts change, please contact us.
