Dear Ms. Vallejos-Landestoy:

You have inquired whether designees of the Board Members of the Youth Task Force are required to file financial disclosure.

As background, Terence Smith, Assistant County Attorney, advises that pursuant to the ordinance governing the Youth Crime Task Force, a board member designee acts "in the full capacity of the appointment, with all its duties and responsibilities, and not as a proxy." Where a board's governing ordinance empowers the designee to act with the full duty and responsibility of a Board Member as is the case here, we concur with the Assistant County Attorney that a designee of one of the Youth Task Force's Board Members would fall within the definition of "advisory personnel" under Section 2-11.1(b)(4) of the County Ethics Code.

With respect to financial disclosures required for "advisory personnel," Section 2-11.1(i)(1) of the County Ethics Code states that:

- "All persons and firms included within subsections (a) and (b)(2), (3) and (4) of this section shall file, no later than 12:00 noon of July 1st of each year including the July 1st following the last year that person is in office or held such employment, one (1) of the following:
  - a. A copy of that person's or firm's current federal income tax return; or
  - b. A current certified financial statement on a form of the type approved for use by State or national banks in Florida listing all assets and liabilities having a value in excess of one thousand dollars (\$1,000.00) and a short description of each; or
- c. An itemized source of income statement, under oath and on a form approved by the County for said purpose.

Compliance with the financial disclosure provisions of Chapter 112 (Part III), Florida Statutes, as amended, or with the provisions of Article II, Section 8 of the Florida Constitution, as amended by the

voters on November 2, 1976, and any general laws promulgated thereunder, shall constitute compliance with this section." (Emphasis added).

Consequently, as "advisory personnel," under Section (b)(4) of the County Ethics Code, the designees of Youth Task Force board members would be required to file one of the above referenced documents to satisfy the financial disclosure requirement. I am attaching a copy of the Financial Disclosures Chart Prepared by the Commission on Ethics, which provides a summary of State and County financial disclosure requirements

and includes hyperlinks to all of the forms. Please remember that any board members or designees who are required to file financial disclosures pursuant to State Law (State Form 1 and State Form 6), satisfy the County Ethics code requirement and do not have to also file a County Source of Income form.

As such, it is my opinion that they are also an "advisory personnel" under the Conflict of Interest and Code of Ethics Ordinance and therefore must file their financial disclosure form. Notwithstanding my opinion, please be advised that the County Attorney's Office is not the final arbiter on matters arising under the Conflict of Interest and Code of Ethics Ordinance.
