Subject: INQ 16-112 Juan Kuryla, Port Director, Port/Miami (Travel Expenses)

Mr. Kuryla,

You have inquired concerning whether you may accept from Regent Seven Seas Cruises (Regent) a complimentary 8night cruise which will be the inaugural cruise of a new ship of that cruise line, Seven Seas Explorer. You have indicated that the offer includes complimentary passage for your wife on the cruise, which is scheduled to depart on July 12, 2016.. Regent is one of the cruise lines operating from Port/Miami and has a contractual lease agreement with Miami-Dade County in connection with its operations there, and over which you are the chief supervisor on behalf of the County. It is understood that you have been invited to participate in this cruise due to your official position as Port Director, and that you would be expected to participate in an inaugural ceremony at the Port prior to embarkation, and that there would be other events taking place during the cruise in which you would be expected to participate in your official position.

Because Regent is a County contractor and as Port Director you are subject to Section 2-11.1(w) of the County Ethics Code, you could not accept this travel expense paid for by Regent unless the Board of County Commissioners were to waive the prohibition under Section 2-11.1(w). Without such a waiver, the prohibition would extend to any transportation, lodging, meals, registration fees and incidentals provided by Regent. There would be no prohibition involved in the event that you were to pay for the cruise yourself. The prohibition would also not apply in the event that the County deemed it an appropriate expenditure having a legitimate public purpose, although it is highly unlikely that payment by the County for your wife's passage would be an appropriate County expenditure.

This opinion is consistent with previous opinions provided by this agency. See INQ 15-182, INQ 15-180, RQO 05-110.
