Dear Mr. Livingstone:

You have inquired on behalf of a member of the Parks and Recreation Citizen's Advisory Committee (PRCAC) whether PRCAC members are required to file financial disclosure on a yearly basis. This question arose because the County Clerk of the Board's (COB) Appointment System (CBAS) indicates that PRCAC is exempt from financial disclosure because they are not required to file State Form 1. As background, the PRCAC was created in 1994 and has been an active County board since that date.

The Miami-Dade Code at Section 2-11.36.1(a) includes in the definition of the term "board", citizen advisory groups in existence for a year of more. Given that the PRCAC has been in existence since 1994, it would be considered a County Board. Please note that all County Boards are covered by the County Ethics Code. Miami-Dade Code § 2-11.39.2. Therefore, PRCAC board members are required to file financial disclosure no later than 12:00 noon of July 1st of each year. Miami-Dade Code §2-11.1(i).

With respect to whether PRCAC members file State of Florida financial disclosure forms, we contacted the Florida Commission on Ethics who advised, upon reviewing the PRCAC ordinance, that its members would not generally fall into the category of parties required to file State financial disclosure forms unless they hold **another position** that requires them to file State financial disclosure forms. If a PRCAC member holds another position that requires him or her to file State Form 1 or State form 6, filing either of the forms would satisfy the financial disclosure under the County Ethics Code. Otherwise, PRCAC members must file a County Source of Income Statement or a copy of their income tax return with the County Department of elections by 12 noon of July 1st of each year with the County Elections Department.

We are providing a copy of this opinion to the Clerk of the Board in order to clarify this matter. I have also attached a Financial Disclosure Chart prepared by the Ethics Commission on a yearly basis which details financial disclosures requirements and provides links to each of the forms.

I am researching if some other exemption would apply that would excuse PRCAC members from filing financial disclosure.
