This will confirm our conversation regarding whether Commissioner Juan Zapata needs to do anything other than file the requisite State disclosure Form 8B following his recusal due to a voting conflict to be in compliance with Section 2-11.1(d) of the County Ethics Code. Based upon the recent ordinance change sponsored by Commissioner Levine Cava, the County Code requirement regarding the procedure following a voting conflict recusal by an elected official now includes the State requirement for announcing the conflict in advance and disclosing it also in a filed form within 15 days of the vote. It is sufficient that Commissioner Zapata file the Form 8B with the Clerk of the Board. There is no other form required under County Ordinance.
