Dear Ms. Hall,

You inquired whether a volunteer ministry speaker/teacher who may receive donations or "love offerings" from attendees at her workshop is subject to outside employment regulations.

The Miami-Dade County Code at Sec. 2-11 requires all full-time employees to seek yearly permission before engaging in outside employment. *See also* Admin. Order 7-1. Additionally, the County Ethics Code at Sec. 2-11.1(k)(2) requires the employee to complete a financial disclosure form on a yearly basis. The Ethics Commission has opined that receiving a donation or "love offering" while serving as a volunteer for a church constitutes outside employment. *See* INQ 05-30; *See also*, Ethics Commission's "Outside Employment Guidelines Memorandum (2014)" attached herein. Consequently, the employee must request permission on a yearly basis to engage in this service and must file the financial disclosure on a yearly basis, providing the amount of the "love offerings" as the compensation.

This opinion is based on the facts presented. If any of these facts change, please contact us.
