#### Ms. Romano:

You have inquired concerning whether a voting conflict of interest would be created in regard to the appointment of Meg Daly to the selection committee for the Marketing Services RFP at JHS. The inquiry is prompted by the following circumstances: 1) Ms. Daly is the CEO/President of Friends of the Underline, a non-profit organization, and one of the Directors of that organization, Josh Merkin, serves as Vice President of rbb Communications, one of the firms responding to the RFP; 2) rbb has donated services to Friends of the Underline, providing pro bono marketing services in the approximate value of \$25,000 to that organization. You have also informed that a member of the Public Health Trust (PHT) Board of Trustees sits as a member of this selection committee. Also, Ms. Daly has indicated that the CEO/President position she holds with the non-profit organization is unpaid.

A selection committee formed by a County agency is considered to be an advisory board of the county for the purposes of assessing a voting conflict of interest under Section 2-11.1(v) of the County Ethics Code. That section requires, for the purposes of determining a voting conflict, that the board member be directly affected by the action of the board **and**. that the member have one of the following relationships with any of the persons or entities appearing before the board: (i) officer, director, partner, of counsel, consultant, employee, fiduciary or beneficiary; or (ii) stockholder, bondholder, debtor or creditor." It does not appear that Ms. Daly would be directly affected by the vote. The fact that a respondent is one of the Directors having supervisory authority over her as CEO of a non-profit organization (for which she receives no remuneration) may raise concerns regarding her ability to be impartial, that connection does not create a "direct" effect on Ms. Daly. Also, Ms. Daly, while being an officer of Friends of the Underline, is not barred from voting due to that relationship, since it is rbb Communications which is appearing before the board, and she has none of the indicated relationships with rbb.

As a member of a County selection committee, however, Ms Daly is subject to Section 2-11.1(j), which prohibits County personnel from having any employment "which would impair his or her independence of judgment in the performance of his or her public duties." It is a legitimate concern that Ms. Daly's position (which, though unpaid, is still a form of employment) and its relationship to that of a Director of the agency, who serves as Vice President of a company coming before the board and which has contributed services to her organization, could interfere with her independence of judgment in making a decision regarding that company's application under an RFP. Further, Article III, Section 3, of the PHT by-laws create a "heightened conflict of interest standard" for its board members, which includes even an "appearance of impropriety" level of scrutiny. Although the selection committee members themselves are not bound by

this heightened standard, the fact that one of the committee members is a Trustee who is bound by that heightened standard, causes me to look to that standard in connection with the activities of this board.

Based upon the apparent conflict between Ms. Daly's interest in maintaining a positive working relationship with the Vice President of abb, and the necessity that she exercise judgment entirely independent of any outside relationships as a member of this selection committee, it is my conclusion that she should not serve as a member of this board. Of course, this in no way implies any negative assessment of Ms. Daly's character or ethics, only a concern caused by the relationship that she brings to the board based upon her private position in a firm that has an officer serving in a closely related position to her private position.
