Mr. Weiss:

You have inquired on behalf of Miami-Dade County Mayor Carlos Gimenez regarding the letter included below, pursuant to which the Mayor would dispose of 500 complimentary tickets to a professional soccer game received at his office unsolicited in an envelope containing the business card of a "J. Santiago," identified as an Account Executive with the Miami Football Club. There is no face value indicated on the tickets, but it is obvious that the tickets have a collective value in excess of \$100. You have indicated that there is no indication that the County has any contractual agreement with the Miami Football Club, and that there are no registered lobbyists in the County representing Miami Football Club.

In the event that Miami Football Club is a County vendor or contractor or employs a lobbyist in the County, the Mayor could not accept these tickets, as Section 112.3148, Florida Statutes prohibits elected officials from accepting any gift valued at over \$100 from a County vendor or lobbyist.

Since the tickets have not been provided pursuant to any agreement with the County whereby they would constitute legal consideration under an existing County contact (which would make them County property which could be disposed

of by him for any valid public purpose), they are considered to be a gift to the Mayor under Section 2-11.1(e) of the County Ethics Code. The Mayor would not be prohibited from accepting the gift and transferring the gift to the YMCA, as proposed. However, under either scenario, the Mayor would be required to report the gift of the tickets under Section 2-11.1(e)(4) of the County Ethics Code since they were provided directly to him without consideration and their value exceeds \$100.

In the event that the Mayor elects to return the tickets to the Miami Football Club he would not be considered to have received a gift and there would be no disclosure requirement.
