Mr. Gonzalez:

There is no exception in the Cone of Silence for a Selection Committee Member who also sits as a public official on an elected public board, in which capacity he or she may be called upon by constituents to speak on a pending procurement matter while the Cone is in force. However, there is an exception under Section 2-11.1(c) of the Code for communications made in publicly-noticed meetings. I would suggest, therefore, that you confine your remarks regarding this solicitation to either publicly-noticed meetings of the Coconut Grove Village Council, or that you arrange with your clerk to provide appropriate public notice for any special meeting that is held by you with constituents.

In the future, you may wish to reconsider whether it is prudent to accept a position on a County selection committee where it will limit your ability to communicate freely with your constituents.

Dear Mr. Gonzalez:

You have inquired, in your capacity as an appointed member to a Miami-Dade County Selection Committee for a county project (Frankie Shannon Rolle Building), regarding whether you may respond to questions about the project from individuals within the community, who may be reacting to initiatives by the principals involved in the procurement process to gain community support. As a member of a County selection committee, you are under the County Cone of Silence in Section 2-11.1(t) of the County Ethics Code. You should not engage in conversations about the selection process with interested parties, including communications with any potential service provider or contractor, lobbyists, County staff or elected officials. While the Cone does not specifically mention communications with members of the public, the requested communications mentioned by you, which you have reason to believe were triggered by community outreach efforts of principals' engaged in the process, should be avoided by you while the Cone is in place. The Cone, which is imposed beginning with the advertisement of the project, continues in effect until the Mayor makes

a written recommendation to the Board of County Commissioners on the project. Until the Cone is lifted at that time, you are advised to avoid engaging in any conversations about the recommendation with anyone inquiring about it. Until the lifting of the Cone at that time, your response to such questions should simply state that, due to the Cone of Silence, you are prohibited from engaging in such communications while the Cone is in effect.
