Martha Garofolo, a Procurement Contracting Officer working for Miami-Dade County Internal Services Department, inquired concerning whether any ethical issues could be raised by her son registering his company, a T-shirt printing business, as a County vendor. We had a discussion with Ms. Garofolo advising her that ethical issues will likely be raised in this scenario under Section (c) of the Miami-Dade Ethics Code which prohibits an employee or his or her immediate family member from entering into a contract with the County if the employee works in the County department which will enforce, oversee or administer the contract. Additionally, ISD, the department that Ms. Garofolo works for, validates/approves and registers all vendors that do business with the County.

Under these circumstances, we did not believe that her son could register as a County vendor, as the department that will approve his application is in fact the department that his mother, Ms. Garofolo, works for. We also forwarded her the form that must be filled out by relatives of procurement employees wishing to do business with the County. Ms. Garofolo later advised that her son was no longer seeking to become a County vendor and withdrew her request for an ethics opinion.
