Hope you and your family are well. You inquired whether local officers who file State Form 1 for financial disclosure satisfy the County Ethics Code by filing a State Form 9.

Local officers required to comply with State requirements (State Form 1 and State Form 6) file State Form 9, the Quarterly Gift Disclosure form, with the Florida Ethics Commission. Local officers are defined by Florida Statute 112.3145 (1)(a)(2016). Please note that Section 2-11.1(e)(4) of the County Ethics Code requires that "local officers" file a copy of the form required by Chapter 112 with the County Clerk of the board.

Municipal Officers that have filed a State form, satisfy the County Code. They <u>do not</u> have to file a separate <u>County</u> form with their local municipal clerk. Compliance with the with the State Law Automatically Satisfies the County Ethics Code, but compliance with the County Code does not satisfy State requirements. *See* INQ 11-65
