## Dear Ms. Bofill:

You have inquired whether members of the Miami-Dade Taxi Advisory Board ("TAB") would file a State Form 6 or whether they would file the local form, the Source of Income form.

The TAB serves as an **advisory board** to the Board of County Commissioners on matters relating the local transportation for hire (taxi) industry. It is comprised of County Employees and local industry representatives. We understand that the TAB members have generally filed the local financial disclosure form the Source of income. However, a question arose whether they should file State Form 6.

Generally, those who file State Form 6 are elected constitutional officers as defined by state law as well as expressway authorities, bridge authorities, and regional transportation authority boards created by state statutes (Chapters 348 and 343, Florida Statutes). Although the County Ethics Commission cannot provide final opinions on matters relating to state financial disclosure statutes, we note that the Taxi Advisory Board is created pursuant to Miami-Dade ordinance 31-84(a)(9) (see also R-599-12 and R-632-14) as an advisory board to County officials on matters regarding the local taxi industry and therefore does appear to fall within the expressway authority designation or regional transportation authority boards that are regulated by Chapters 348 or 343. The Florida Commission on Ethics could be consulted to provide any final determination on matters relating to State forms 1 and 6.

Thus, members of the TBA would ordinarily file the local source of income form unless another position they hold subjects them to the state financial disclosure statutes. For example, County employees that serve on this board would file a State Form 1 if, in their County positions, they have final authority over expenditures of more than \$20,000. See § 112.3145(1)(a) Fla. Stat. (2016). Similarly, the other board members would file a State Form 1, if **other** duties they perform would make them subject to Florida Statute 112.3145 (for example service on another board that is covered by the state statute, serving as an elected official, etc.); otherwise, they would file the local Source of Income form.
