Beth Spiegel, City Commissioner for the City of North Miami Beach, inquired concerning whether during the pendency of the Cone of Silence, imposed during the procurement process for the contracting out of the City's water and wastewater utility, she could respond to an inquiry from the media concerning the contract and questions raised about the leading firm that is about to be designated for negotiation that could lead to a recommendation on to the Commission for award of the contract.

I advised Commissioner Spiegel that the County Cone of Silence, Section 2-11.1(t) of the County Ethics Code, applicable to the City of North Miami Beach due to the City's not having opted out of the Cone, only restricts communications between certain designated parties involved in the procurement--lobbyists, contractors, consultants, professional staff, selection committee members, Commissioners or their staffs. Since the media is not covered by the prohibitions under the Cone there is nothing in the Cone that would prohibit her communicating with the media concerning the procurement while the Cone is in effect.

However, I also advised Ms.Spiegel that, given the nature of the Cone and its purpose of preventing undue political and private influence over the selection/evaluation process on a procurement, she may want to consider refraining from extensive comment on a pending procurement that could be perceived as an attempt to influence the process during the pendency of the Cone.
