Dear Mr. Callwood,

You have inquired whether a conflict of interest would exist were you, a part-time employee working as a console security specialist for the Miami-Dade Internal Services Department, to engage in outside employment as a security officer for Security Alliance, LLC, a County vendor.

The Miami-Dade Commission on Ethics & Public Trust during a public meeting on May 11, 2016, opined that, *with limitations*, your proposed outside employment as security officer for Security Alliance, LLC, a County vendor, is not likely to conflict with your duties to the County as a part-time console security specialist. See RQO 16-02.

You have represented that the basic facts that formed the basis of that opinion have not changed, as you have the same duties and responsibilities in both jobs that were outlined in the opinion. Please be advised that as the basic facts have not changed, the Commission's opinion that *with limitations*, your outside employment is not likely to conflict with your duties to the County, memorialized in RQO 16-02, still stands.

Please also note INQ 16-121, which states that, pursuant to County Administrative Order No. 7-1, you must obtain approval for outside employment from your Department Director/Supervisor. We have attached both RQO 16-02 and INQ 16-121 for your review.
