Dear Mr. Osborne,

You inquire whether assisting a friend by engaging in gardening and household tasks, where the friend compensates you for your services, constitutes outside employment. It is not clear whether this will be a one-time isolated undertaking or an activity you intend to do on a regular basis. **Assuming the latter**, this activity is akin to the work of a "caregiver". There are in fact several community service programs and online providers, such as <u>care.com</u>, which assist the elderly by providing chores such as yardwork, lawn mowing, grocery shopping, house cleaning and minor home repairs for a fee. I refer you to the below response- INQ 17-75, where I indicated to you that, "[o]utside employment is considered any non-County employment or *business arrangement* in which the County employee provides a personal service that is *compensated or customarily eligible to be compensated*." *See* Outside Employment Memorandum 2014. Consequently, assisting in gardening and other household tasks for someone else *on a steady and constant basis* where you are compensated for these services is outside employment and you must obtain annual approval from your supervisor and complete an outside employment statement. *See* below. On the form, you may indicate that you are "self-employed" as a "caregiver"

Dear Mr. Osborne,

You inquire whether you are engaged in outside employment when you are paid for your performance of electronic music at various local venues or convention(s).

Background

You are employed as a Librarian Assistant III for MDC Public Libraries. As stated in your email, one of your *hobbies* is to make electronic music. On occasion, you would like to perform your electronic music in public venues **for a fee**, although you are not necessarily included in the venue's payroll.

<u>Analysis</u>

As an electronic music performer you will be compensated for your service/ performance. Outside employment is considered any non-County employment or business arrangement in which the County employee provides a personal service that is compensated or customarily eligible to be compensated. *See* INQ 13-08; Outside Employment Memorandum 2014. Consequently, if you will be compensated for your music performance at various venues, you must obtain approval for outside employment from your supervisor by completing a Request for Outside Employment form. Once permission is obtained, you must also file an annual "Outside Employment Statement" with the County's Department of Elections.

This opinion is based on the facts as presented and is limited to the question of whether the described activity constitutes outside employment and does not address any issues regarding conflicting employment. If any of these facts change, please contact us.
