Ms. Rambeau:

You have inquired concerning whether, as a part-time employee of the African Heritage Cultural Arts Center, an agency within Miami-Dade County government, you may qualify as a candidate for the Miami-Dade County School Board. Although this matter does not appear to involve a conflict issue under the Miami-Dade County Conflict of Interest and Code of Ethics, you should be made aware of the provisions of Section 1.05 of the County Charter. That provision states under Subsection C that, "Any appointed official or employee of Dade County who qualifies as a candidate for election to any federal, state or municipal office shall immediately take a leave of absence from his or her county position until the date of the election and shall, if elected, immediately forfeit his or her county position. If the candidate is not elected, he or she shall immediately be reinstated to his or her former position." This provision does not appear to except part-time employees from its prohibition. Since the School Board is created under Article IX of the State of Florida Constitution, School Board positions are considered constitutional offices of the State of Florida. Therefore, it appears that you would be required to take a leave of absence from your County position in the event that you qualify as a candidate for the Miami-Dade County School Board.
