Dear Ms. Regalado:

You have inquired whether a board member appointed to a County board, the Miami-Dade Domestic Violence Oversight Board ("DVOB"), would be required to file the State of Florida Quarterly Client Disclosure form (Form 2). This form is only filed by persons who are required pursuant to Florida statutes to file State Forms 1 or 6. Those that file the local County Source of Income form do not file State Form 2.

If the board member files a State Form 1 or 6 because of his or her service on a state board or any other service that would require him to file the State financial disclosure forms, then he or she would also be required to file a Form 2. However, it is my understanding that members of the Domestic Violence Oversight Board generally file the local County Source of Income form (SOI) pursuant to the County Ethics Code at section 2-11.1(i). Filers of the local County SOI form do not file State Form 2.

A final determination on whether a board member would be required to file State Forms 1 or 6 because of his or her service on the DVOB and whether that board member would thus also be required to file a State Form 2, would be under the jurisdiction of the Florida Commission on Ethics. It would be very helpful if you sent us a copy of any response you might receive form the Florida Commission on Ethics so that we could include it in our records for future inquiries.

Per our phone conversation, I have a question regarding the forms we are required to provide and execute as members of the DVOB. I understand that we have to provide the financial disclosure form, which I don't have a problem with. However, I am unsure of whether I need to file the Quarterly Client Disclosure (Form 2) provided none of my Firm's clients appear before the DVOB. As you know, our firm has a robust practice before the county commission, where we regularly represent clients on procurement, regulatory and land use matters. As a law firm, our firm has a general policy against

disclosing any client information. Thus, if service on the DVOB would require me to disclose on a quarterly basis the clients of the firm that we represent before the county commission, I would have to regretfully decline the appointment to serve on the DVOB. Please advise at your earliest opportunity whether or not this requirement would apply to me. I will wait for your response before filing my oath of office or the financial disclosure form.

<u>Form 1-</u> Local Officers subject to Financial Disclosure by the State of Florida (and candidates for these offices) are required to file a Form 1. Additionally, County employees authorized to approve expenditures exceeding \$20,000 (including electronic signature approvals in ADPICS and FAMIS) are required to file this form.

<u>Form 1F-</u>Final Statement of Financial Interests 2015: Individuals who are required to file a Form 1 are required to file a Form 1F no later than 60 days after leaving that position, unless another position with a Form 1 or Form 6 requirement is taken within the 60-day period.

Other State Financial Disclosures Forms-Additional forms that State filers may need.
