Subject: INQ 17-207 Marcos Villanueva, City Commissioner, City of Sweetwater (Voting Conflict)

Commissioner Villanueva:

You have requested an opinion from this agency concerning whether you would have a voting conflict of interest under Section 2-11.1(d) of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance for you to participate in and vote on a matter coming before the Sweetwater City Commission involving consideration of a request by a former police officer of the City of Sweetwater to be reinstated to his police position. You have informed that you were the supervisor of the officer at the time he engaged in actions leading to his termination from the force, and that you have information to present to the board regarding those circumstances that would be deemed relevant to the decision before the board. You have also indicated that you are a personal friend of this officer and that he has contributed to your political campaign.

Section 2-11.1(d) of the Code of Ethics covers voting conflicts of interest on the part of elected public officials who are members of a local government board. There are a series of relationships listed in that section, including officer, director, partner, of counsel, consultant, employee, fiduciary, beneficiary, stockholder, bondholder, debtor and creditor, which, under certain circumstances, could create a legal voting conflict of interest under that section. Former supervisor, personal friend, and campaign contributor are not among those relationships. Further, you would have a legal voting conflict of interest under that section, if you "would or might, directly or indirectly, profit of be enhanced" by the vote. Nothing you have revealed to us indicates that you have the type of personal interest in this matter that could lead to personal profit or enhancement.

Accordingly, I have concluded that, under the circumstances related by you, you do not have a legal conflict of interest under the Ethics Code that would prohibit you from participating in the discussion and vote on this matter. However, there is one important caveat that should be added to this conclusion.

Under Section 286.012, Florida Statutes, even if you do not have a legal voting conflict on a matter, if the issue involved occurs in the context of a quasi-judicial proceeding, you may abstain from voting on that matter "if the abstention is to assure a fair proceeding free from potential bias or prejudice." I provide this section to you because the nature of the proceeding described by you, that of a hearing to determine whether an former officer should be reinstated to the City of Sweetwater Police Department, appears to have some of the characteristics of a quasi-judicial proceeding. If it involves an evidentiary hearing before the Commission, after which the board will take a vote adjudicating certain rights of the individual applicant before it, then there is a likelihood that this would be considered a quasi-judicial proceeding. Furthermore, you have indicated that it is your intent to provide testimony at this hearing based upon your personal knowledge of the circumstances surrounding the officer's termination. A board member sitting in a quasi-

judicial proceeding is expected to base his or her decision strictly on an impartial evaluation of the evidence presented before it. If an individual effectively plays the role of a witness who provides testimony on behalf of an applicant before that board, then it is questionable whether that board member is in a position to provide an impartial evaluation of the evidence, given that the evidence consists in part of his or her own testimony provided on behalf of an interested party.

While I cannot conclude that you have a voting conflict of interest that would prevent you from voting on this matter, I do suggest that you confer with your City Attorney regarding whether it would be appropriate for you to recuse yourself under these circumstances.
