Dear Mr. Schoonmaker,

You have inquired as to whether the Miami-Dade Commission on Ethics and Public Trust (COE) contacts individuals that have previously taken the lobbyist ethics training courses to inform them that their ethics training may possibly have lapsed.

No, the COE does not contact each individual after they have taken the various lobbyist ethics training courses to inform them that their ethics training may have lapsed. The frequency that a lobbyist must take the ethics training course and refresher ethics training course varies depending on the jurisdiction (County or municipality) that the individual lobbies.

With respect to lobbying the City of Miami, the City's lobbyist ordinance requires lobbyists to complete ethics training on a **yearly basis**. City of Miami Code §2-654(a).

With respect to Miami-Dade County, the County Ethics Code requires completion of a refresher course every **two-years**. Miami-Dade Code §2-11.1(s)(2)(d).

Lobbyists are provided this information during the various ethics training courses that the COE conducts. They are also provided an ethics training certificate at the end of each course that memorializes the date that they completed the course. It is then up to the individual lobbyist to keep track of when their training will lapse based on the jurisdiction (County or City of Miami) that the individual lobbies.
