Dear Mr. Kimble,

You have inquired as to the definition of "intent" in relation to violating the County Ethics Code. You are a Courtroom Clerk I, at the North-Dade Justice Center. You indicated that your question does not relate to any specific circumstance but rather generally formed while you were viewing the County online ethics training video, as one of the presenters mentioned the word "intent".

The County Ethics Code does not provide a specific definition of the word "intent". However, Black's law dictionary defines intent as "purpose; formulated design; a resolve to do or forbear a particular act; aim; determination....It is the exercise of intelligent will, the mind being fully aware of the nature and consequences of the act which is about to be done, and with such knowledge, and with full liberty of action, willing and electing to do it."

As noted in the online ethics training, the Commission on Ethics can impose enhanced penalties if they determine that an individual intentionally violated a section of the Ethics Code. They have generally looked at the circumstances surrounding the misconduct in order to make the determination as to whether enhanced penalties should be applied.
