It was a pleasure to speak with you over the phone. You inquired whether a County employee who serves in the United States National Guard is considered to be engaging in outside employment.

As we discussed, the Commission on Ethics ("COE") has previously determined that active or reserve military service is not considered outside employment. See RQO 14-03. I am attaching the Outside Employment Guidelines Memorandum prepared by the COE for informational purposes. The issue of military service is included in the memorandum.
