You have inquired regarding whether your acceptance of a complimentary admission to the Grand Bench & Bar Conference, sponsored by the Dade County Bar Association, would be a reportable gift pursuant to Subsection 2-11.1(e)(4) of the County Ethics Code. The complimentary admission is valued at \$250 and is being offered by the Dade County Bar to individuals whose membership status with the Bar Association has lapsed, as an incentive to their lapsed memberships. I would view this offer as similar to the one that you previously inquired about in INQ 16-116, involving an offer by the Bar Association to prospective members of the Association of "Bar Bucks" redeemable for use at Bar functions, as an incentive to their joining the Association, with the consideration being their paid memberships. The free admission is being offered to a class of individuals, those with lapsed memberships, as an incentive to their renewing their memberships, and not with the intent to bestow a gift on any individual. I believe that the consideration of membership renewal is adequate consideration for the complimentary admission. Therefore, I would not view this as a reportable gift pursuant to Subsection 2-11.1(k)(4).
