Ms. Starkey:

You inquired concerning whether you and other students at UM, who are engaged in a legislative project with the Center for Ethics and Public Service at UM, may be involved in proposing and speaking on behalf of legislation at the City of Miami that was developed through your participation as a student at the UM Center. You have indicated that you and the other students involved in the project are not doing so as the representatives of any individual or organization intending to influence the legislative process. It is my opinion that, under these circumstances, you and each of the students involved in this project, would be appearing as individuals to express your views on this legislation before the City's legislative body. Under both the County Code of Ethics, Subsection 2-11.1(s)(3)(b), as well as the City of Miami Code, Section 2-653, a person appearing before the City Commission in his or her individual capacity for the purpose of self-representation, and without compensation or reimbursement from another person or entity, to express support of or opposition to an item, is not required to register as a lobbyist. Therefore, it is my opinion that you and you fellow students need not register as lobbyists to introduce and speak on behalf of the legislation before the Commission.
