Ms. Whiteside:

This is in response to the memo Thomas B. Davis of the Office of Commission Auditor regarding the background check on the selection committee members for Project No. E17-TPO-02, 2045 Long Range Transportation Plan, Miami-Dade Transportation Planning Organization. In that memo Mr. Davis referenced the connection of one of the selection committee members, Ms. Nilia Cartaya, who informed that she had previously worked for The Corradino Group, a listed vendor on the project, between 2004 and 2006. I followed up with Ms. Cartaya and discussed her involvement on the committee in light of this information.

It is clear that Ms. Cartaya does not have any legally recognized voting conflict of interest under Section 2-11.1(v) of the County Ethics Code that would prevent her from serving on this committee based upon her previous employment by Corradino Group. She does not have any present relationship with any vendor or affected party, nor is she in any way directly affected personally by the decision-making process for this project.

However, Ms. Cartaya has indicated to me that she has a concern that, although she would endeavor to be fair to all applicants if she were to serve on the committee, she is uncertain as to whether her prior connection with Corradino Group would not affect her objectivity and ability to judge all applicants fairly. The procurement process in the County, as you are well aware, strives to follow procedures that not only abide by the ethics code, but also serve to promote the highest values of integrity, transparency and fairness. This agency, pursuant to Resolution No. R-449-14, as well as Commission on Ethics Rule of Procedure 2.1(b), has provided input concerning appearance

issues when they may raise a question regarding the objectivity of a selection committee member. Based upon my conversation with Ms. Cartaya, it is my recommendation that she not be required to serve on this particular committee due to her previous employment with Corradino Group. This recommendation should not in any way be interpreted to suggest that Ms. Cartaya, whose honesty and candor in this matter are appreciated, would not be a suitable or appropriate person to serve on a different selection committee for a project that did not involve Corradino Group as a listed vendor.
