This is in response to your request for guidance in regard to a pending matter in North Bay Village regarding the Village's taking over the guard house on North Bay Island. You have asked for an opinion due to the fact of your being a resident on North Bay Island. You have indicated that there are 290 residents on the island. The effect of the this issue is relegated specially to the residents of the island.

Based on the information you have provided and the nature of the issue, it is my opinion that you do not have a voting conflict of interest in participating and voting on this item. You do not have any prohibited relationship with a person or entity involved in the matter under Section 2-11.1(d) of the Ethics Code. Your interest in the issue may be stronger than the interest of NBV residents who do not live on the island, but it appears to me that it is no different than the interest of the other residents of the island who number close to 300. The general rule we have followed in assessing possible voting conflict of this nature would not find a conflict where the interest of the official who is among those specially affected by a measure is less than 1-2% of the entire number of affected residents. Therefore, I do not see any likelihood that you would personally profit or be enhanced, directly or indirectly, by voting on this matter. If you had some personal or financial interest in the project that would differ in some significant way from the interest of the other residents of the island, then this opinion might be different. However, I am assuming for the purpose of your request, that your interest in the issue does not materially differ from that of the other residents of the island.

Accordingly, you may participate in the discussion and vote on this matter.
