As I understand this event, although it occurs on a cruise ship, there is no actual travel involved, i.e., the ship will remain in port and all events will take place on the ship. Therefore, the prohibition in Section 2-11.1(w) of the Ethics Code regarding acceptance of travel and travel-related expenses from county contractors would not apply since there is no travel or travel-related expense being provided by MSC Cruises, the entity with which the County has a contract.

Further, I see no prohibition in Section 2-11.1(e) that would prohibit management staff from attending this event. It is completely consistent with the duties of the management staff to be in attendance for local events, such as this one, which commemorate notable events at the Port. In my opinion, this event directly involves the County and County interests, and the presence of certain Port staff at this event serves a County purpose. For Port Management not to be in attendance at such an event could even be considered a dereliction of duty. Therefore, I do not consider this to be gift, but rather an event that requires County participation.
