Dear Mr. Kelly:

You inquired about limitations on transacting business that would apply to your spouse's company, G Kelly's Enterprises, LLC. which is seeking to bid on a County inkjet cartridges solicitation. You are employed as a <u>Senior Telecommunications Technician</u> with the <u>Miami-Dade County Information Technology Department ("ITD"</u>). We discussed this matter over the phone and this email will serve as a confirmation of our conversation.

As background, G Kelly Enterprises LLC. is seeking to respond to a County solicitation for laser and inkjet cartridges recycling services which is intended to be a replacement contract for collecting/recycling various cartridges from multiple Miami-Dade County departments. The contract's solicitation, selection, oversight, and administration will be done solely by the ISD Procurement department and by the Miami-Dade Community Action and Human Services Department ("CAHSD"). The contract that will result from this solicitation will be in support of Resolution R-974-02, Miami-Dade County Summer Youth Jobs Program. All proceeds from recycling cartridges would go towards this Youth Program.

The County Ethics Code at Sections 2-11.1(c)(2) and (d) allow G Kelly Enterprises LLC to enter into a contract, individually or through a firm, with Miami-Dade County, as long as the contract does not interfere with the full and faithful discharge of your employment duties to the County and as long as neither you nor the department that employs you are involved in the contract in any way including, but not limited to, its enforcement, oversight, administration, amendment, extension, termination or forbearance. In this case, there is no conflict because the contract will be administered solely by CAHSD and neither ITD nor you will be involved in any aspect of this contract.

In addition, you may not use your County position to secure **special privileges or exemptions** with respect to the contract and you may not lobby the County on behalf of G Kelly Enterprises LLC. *See* County Ethics Code §§ 2-11.1(g) and (m).

This opinion is limited to the facts as you presented them to the Commission on Ethics regarding conflicts under Subsections (c), (d), (g), and (m) of the Miami-Dade Conflict of Interest and Code of Ethics Ordinance only. Other conflicts, based on directives from your Department or under state law, may apply. If you have additional questions regarding possible conflicts based on Department directives, contact your Department supervisor or the Mayor's Office. It was a pleasure to speak with you over the phone. This email will serve to memorialize our phone conversation.

You inquired regarding the definition of the term "immediate family" under County Ethics Code Section 2-11.1(b)(9) and the application of this term to limitations on doing business with the County under Sections 2-11.1(c) and (d). We previously provided an opinion to your spouse (INQ 17-225) regarding her limitations on transacting business with the county though her privately owned company, G Kelly's Enterprises LLC. In that opinion, the Ethics Commission advised Ms. Kelly that because of your employment with the County's Information Technology Department ("ITD"), Kelly Enterprises LLC would be prohibited from doing business with ITD.

You inquired whether the limitations on transacting business with the County set out in the County Ethics Code would also apply to your father-in-law, aunt, uncle, or cousins. These relatives would not be covered by Sections 2-11.1(c) and (d) because Section (b)(9) of the Ethics Code defines the term "immediate family" as "the spouse, domestic partner, parents, stepparents, children and stepchildren of the person involved. "

Nevertheless, Section 2-11.1 (g) of the County Ethics code must always be considered. This section prohibits County employees from using their official position to secure special privileges or exemptions for himself or herself or others except as may be specifically permitted by other County ordinances and resolutions.
