Re: **INQ 17-40**, Limitations on Doing Business with the County

Dear Mr. Garcia:

In a request to our office on January 30, 2017, you asked the Ethics Commission for an opinion regarding your ability to do business with the Miami-Dade County through your privately owned business, Joel Pressure Cleaning and Painting Services Corporation. In your application you indicated that you were employed as a Computer Tech 1 at the Miami-Dade County Department of Elections ("Elections"). However, the Elections Department advises that you are employed by Transhire Transitional Hiring Solutions ("Transhire"), and were assigned to the Elections department as a temporary employee. The Elections Department also informs us that the Temporary Services Contract between the County and Transhire does not state that temporary employees of that company assigned to County departments are covered by the County Ethics Code.

Consequently, Transhire employees assigned to work duties in County departments do not fall within the jurisdiction of the Ethics Commission. Only Miami-Dade County elected officials, board members, and employees, and their immediate family members, are required to obtain ethics opinions from the Ethics Commission as part of qualifying for

eligibility to do business with the Miami-Dade County. Therefore, Joel Pressure Cleaning and Painting is not prohibited from transacting business with the County.
