Dear Ms. Pollock:

It was a pleasure to speak with you. You inquired about ethics training requirements for County board members. Section 2-11.1(bb) of the County Ethics Code requires ethics training for elected officials and County employees, but is silent on ethics training for County **board members**. However, Miami Dade-Resolution 189-05 (attached) states in relevant part that:

"...members of all County boards shall be required to complete an ethics training course which, at a minimum, shall include the following topics: the Conflict of Interest and Code of Ethics Ordinance; the Sunshine Law; and the Public Records Law. The ethics training course shall be developed by the Miami-Dade County Commission on Ethics and Public trust ("Ethics Commission"). All current and future board members shall be required to complete the ethics training course pursuant to a schedule developed by the Ethics Commission."

I note that Resolution 189-05 does not specify a time frame within which the ethics training must be completed; however, you advise that Section 4.15.6 of the by-laws of the Miami-Dade Economic Advocacy Trust, the County board about which you are inquiring, sets a 90 day requirement to complete ethics training. In the absence of a specified timeframe for ethics training in Resolution 189-05, the time frame in your by-laws should be followed.
