Dear Mr. Capelli,

You have inquired whether a conflict of interest exists between you serving as a board member on the Miami-Dade Millennial Task Force (MTF) and your employment as Founder/CEO of TECH Miami Inc. (Tech Miami).

Background

You were appointed to serve as a member of MTF by Miami-Dade County Commissioner Esteban Bovo, Jr. The MTF is an advisory board that was created to develop strategies to attract, retain, and assist millennials in Miami-Dade County through, among other things, housing, career, and transportation opportunities or incentives. The MTF is an advisory only taskforce and does not have the power or authority to commit Miami-Dade County or any of its agencies or instrumentalities to any policies, incur any financial obligation, or create any liability, contractual or otherwise, on behalf of Miami-Dade County or any of its agencies or instrumentalities. It is an unpaid, voluntary board position.

You are also the Founder/CEO of Tech Miami. Tech Miami does research and development on the governance and business model for Smart Cities & Digital Infrastructure; and sourcing and reporting on disruptive emerging (new) technologies and economic impacts for senior government and real estate development executives. Its current research includes strategies around revenue models for building and sustaining Smart City infrastructure versus just cost savings and modernization efforts; developing P3 global frameworks for strategic partnerships to support digital public infrastructure for Smart Cities, in relation to increased automation and leaning of the global labor force leading to dynamically reduced government revenue to support critical infrastructure needs.

Tech Miami is currently listed as a County vendor but does not have any contracts or grants with the County. It has also not responded to any RFPs nor submitted any grant application to the County at this time.

<u>Analysis</u>

Based on the information that you have presented, it does not appear that a conflict of interest exists under the County Ethics Code between your serving as a board member on MTF in which you would be called upon to make recommendations in connection with housing, career, and transportation opportunities and you employment as Founder/CEO of Tech Miami, a technology company. As a County board member you do however have to adhere to the following provisions of the County Ethics Code:

Section 2-11.1(c)(3) prohibits a board member from contracting with any County department or agency that is subject to the regulation, oversight, management, policy-setting, or authority of the board on which they serve.

Section 2-11.1(g) prohibits a board member from using his or her County board position to secure special privileges or exemption for himself/herself or others.

Section 2-11.1(h) prohibits a board member from disclosing confidential information acquired by reason of his or her board position.

Section 2-11.1(m)(2) prohibits a board member, either directly or through an associate from appearing before the board on which he or she serves to make a presentation or seek a benefit (ie. grant or other source of funding) on behalf of a third party. This means that the board member must not "lobby" or try to influence or persuade his/her board for the benefit of a third party.

Section 2-11.1(v) prohibits a board member from voting on matters presented to the board on which the member sits IF the board member would be directly affected by the action of the board he or she serves <u>and</u> he or she has any of the following relationships with the third party: (i) officer, director, partner, of counsel, consultant, employee, fiduciary or beneficiary; or (ii) stockholder, bondholder, debtor or creditor. Consequently, a member of a board may not participate or vote on matters concerning a third party where he or she is an officer.

Additionally, the Florida Sunshine Act as Sec. 286.011, Florida Statutes, prohibits board members from discussing board business except at a duly noticed public meeting where the public is invited and minutes are taken. This means no board business can be discussed before the meeting is called to order or after the meeting adjourns.

Finally, when a board member recuses himself or herself from a vote based on a conflict of interest, as contemplated b Section 2-11.1(v) of the Ethics Code, he or she must:

- 1) Announce publicly at the meeting the nature of the conflict before the item is heard;
- 2) Absent himself or herself from that portion of the meeting during which the item is discussed and/or voted upon; and
- 3) File a written disclosure of the nature of the conflict with the person responsible for recording the minutes of the meeting, within 15 days after the vote. *See* Section 112.3143, Fla. Stat.; *See also*, State Form 8B, "Memorandum of Voting Conflict for County, Municipal and other Public Officers", available at the Florida Commission on Ethics website, <u>www.ethics.state.fl.us</u>
