### Dear Mr. Manduley:

You have inquired whether the Ethics Code would prohibit County employees of the Information Technology Department (ITD) from accepting travel expenses (tickets, airfare and hotel) to Socrata Connect 17 which are included in the renewal agreement between the County and Socrata.

### **Background**

As background, the County has an agreement with Socrata to provide technology related services to the County. Socrata is a data product that the County uses for the County's Open Data Platform. The renewal agreement between Socrata and the County (for a fee of **\$137,608.06)** includes a provision for travel expenses (admission, airfare, hotel) for two ITD employees to attend the Socrata annual conference in Washington D.C. The conference will include training on the data platform, best practices, and meetings with other governmental agencies to discuss how they have solved issues similar to those the County is seeking to resolve.

### Legal Analysis

Section 2-11.1(w) of the County Ethics Code prohibits County employees from receiving travel expenses from County vendors. However, based on the facts presented in this matter, Socrata's payment of travel expenses is not prohibited by section 2-11.1(w). This is because here, the County is providing adequate consideration for the travel expenses through the terms of the agreement; in other words, in essence, the County is paying for these travel expenses through the terms of the agreement. *See* INQ 13-227 (attached).

This opinion is based on the facts presented. If these, facts change please contact us.
